Orientation and Intake Process

The first step in the visitation and/or exchange process with *Safe 4 Us* is to schedule an Orientation. Please call us at (707) 784-7635 or <u>Safe4Us@solanofamilyjustice.org</u> to schedule an appointment. **We see clients by appointment only.** Custodial and non-Custodial parents will attend separate orientations. Custodial parents will bring their child(ren) if they are two years of age or older for a children's orientation.

Orientation is an opportunity for you to get to know us and for staff to get to know you and your needs. You will also have the opportunity to meet one or more of the visitation specialists and tour or facilities.

Fees

Currently there are no fees for services due to grant funding. Fees may be charged for missed visits without 24 hour notice. If services are canceled due to non-compliance with program guidelines, a fee will be assessed to re-enroll in the program. The fee schedule will be based on gross monthly income and will be determined upon our receipt of income verification.

The time of each visit will be determined by the program director and based on the availability of parents, staff and meeting area. Both parents will be consulted on what times and days work best for them.
